



Enrollment Contract 2010 - 2011

This form must be completed by the custodial parent and/or guardian, signed and returned in the registration packet.

REGISTRATION FEE: \$ 500 Non-refundable.

CURRENT STUDENTS: The Registration Fee is due Monday, March 1, 2010.

INCOMING FRESHMEN: The Registration Fee is due with the complete registration packet on either Tuesday, March 23; Wednesday, March 24 or Thursday, March 25, 2010.

Registration is only complete when the signed Enrollment Contract and Registration Fee in full is received in the Business office. Payment of the Registration Fee secures the student's course selections and roster placement until June 16, 2010.

Please note: The Registration Fee is not applied towards tuition.
Consideration for financial aid is only possible after receipt of Registration Fee.

TUITION

The Responsible Party agrees to pay the total of all Tuition and Fees, net of any financial aid or scholarship monies provided on behalf of the Student by one of the options detailed below.

Parish Supporting: \$9,650 (Families with a signed Parish Certification form from a Catholic parish)

Regular Tuition: \$11,580

Student fees and fees for the Tuition Refund Guarantee Plan have not been included in the above tuition rates.

Student Fees are due at the time of tuition payment and are as follows:

TERMS AND CONDITIONS

1. Tuition for all students for the entire school year is due by June 16, 2010 (the "Tuition Deadline") or within 10 business days from the date the student is enrolled but prior to the beginning of the school year. Failure to meet the tuition deadline by payment in full or signed and submitted tuition loan with the approved lending institution will result in the deletion of the student's course schedule.
2. A non-refundable late fee of \$250 is incurred for all tuition funded after June 16, 2010.
3. Tuition must be paid in full or TCCU Tuition Loans must be current for students to:
 - Begin a semester
 - Take semester or final exams
 - Obtain Official transcripts/grades
4. Loans shall be considered in default when they are past due in accordance with TCCU's policy. Nolan is required to repurchase the loan if a family become 60 days delinquent. A \$100 fee will be assessed at the time the loan is repurchased.
5. In the case of tuition shared by divorced/separated parents, it is the policy of Nolan Catholic to furnish the responsible financial party(ies) listed on the Enrollment Contract with the amount of tuition due and notice of subsequent tuition matters. Nolan Catholic High School does not divide tuition between parties or send separate mailings.

PAYMENT OPTIONS

Please indicate your selection next to the appropriate option(s).

OPTION 1 – Cashier or Personal Check Payment
 Payment must be in the form of a personal or cashier’s check.

OPTION 2 – Credit Card Payment
 Nolan Catholic accepts MasterCard, American Express and Discover. Credit card transactions must be processed online at www.nolancatholic.org and are subject to a 3.0 % convenience fee.

OPTION 3 – Texas Catholic Credit Union (TCCU) Loan
 Nolan Catholic High School has made arrangements with Texas Catholic Credit Union (TCCU) to provide tuition loans. It is not necessary to qualify for these tuition loans. Participation in the Tuition Refund Guarantee Plan is required with this payment option. *Nolan Catholic reserves the right to refuse guarantee of a loan*

OPTION 4 – Your Tuition Solution
 Nolan Catholic High School has made arrangements with *Your Tuition Solution*, a third party lender offering extended payment plans up to 84 months. Loan applications are handled through www.yourtutionsolution.com

TUITION REFUND GUARANTEE PLAN

Tuition is non-refundable. However, a Tuition Refund Guarantee Plan is available for purchase. This plan is mandatory if financing is arranged through the Texas Catholic Credit Union.

The cost of the protection is 3.75% of the amount financed or paid and is due at the time of the tuition payment.

The Registration fee, Student fee, Tuition late fee are non-refundable and are not covered by the Tuition Refund Guarantee Plan.

If this plan is purchased and full tuition payment was made, the unused portion of tuition less pro-rated financial assistance will be refunded within 30 days following a student’s official date of withdrawal.

If tuition was funded through TCCU loan, a loan payment equaled to the unused portion of tuition less pro-rated financial assistance will be made within 30 days following a student’s official date of withdrawal.

RETURNED CHECK POLICY

All returned checks are assessed a \$30 fee per check. All checks returned to Nolan Catholic High School for any reason must be paid in full via certified check, money order, cash or credit card, in order for student to

- Begin a semester
- Take semester or final exams
- Obtain Official transcripts/grades

All outstanding financial obligations must be resolved with cash or cashier’s check before official transcripts/grades will be released from Nolan Catholic High School
